3 (a) The objects to be pursued by the company on its incorporation are:

To undertake and promote welfare activities for humanity, including initiatives aimed at improving the living conditions of underprivileged, destitute, differently-abled, elderly, and marginalized sections of society through provision of shelter, food, clothing, healthcare, education, and other essential services.

To engage in animal welfare activities, including rescue, shelter, food, medical treatment, vaccination, and adoption support for stray, injured, or abandoned animals; and to promote awareness on humane treatment of animals and ecological balance.

To establish, operate, or support shelters, rehabilitation centers, healthcare camps, and community service units for the welfare of humans and animals, particularly in rural, tribal, and underserved areas.

To collaborate with government departments, local bodies, and other non-governmental organizations in implementing welfare and developmental programs for the holistic well-

being of people and animals.

To assist in the preservation, renovation, and maintenance of public heritage structures and community places of cultural, spiritual, or historical significance, ensuring they are accessible and beneficial to the public at large.

To promote environmental protection and cleanliness in and around such community or heritage sites, including afforestation, waste management, and sustainable upkeep initiatives.

To organize awareness programs, training, and volunteer initiatives encouraging citizens participation in humanitarian, animal welfare, and heritage conservation activities.

(b) *Matters which are necessary for furtherance of the objects specified in clause 3(a) are

1. To organize seminars, workshops, training programs, and awareness campaigns in furtherance of the main objectives of the company, especially in underserved and marginalized communities.

2. To collaborate with governmental, semi-governmental, non-governmental, academic, and other institutions or organizations for knowledge exchange, capacity building, and implementation of socially impactful initiatives.

3. To publish newsletters, journals, research papers, books, reports, audio-visual content, and digital publications aimed at spreading awareness, education, and information consistent with the company's objectives.

4. To conduct surveys, field studies, impact assessments, and evaluation exercises to document progress and identify

areas for improvement related to the company's activities.

5. To recruit, appoint, or engage professionals, trainers, consultants, staff, interns, and volunteers necessary to carry out the programs and operations of the company.

6. To support and organize public events, including exhibitions, fairs, conferences, and campaigns, that promote public interest, education, and awareness consistent with the objects of the company. To accept voluntary contributions and assistance from lawful sources for promoting and carrying out the charitable objects of the company.

7. To establish and operate educational, wellness, or resource centers, including community hubs, learning spaces, libraries, helplines, or information kiosks that align with the public welfare objectives of the company.

8. To develop and distribute educational and awareness materials, including guides, posters, manuals, toolkits, and digital content to enhance knowledge and positive behavioral practices.

9. To build cooperative relationships among stakeholders, including civil society organizations, academic institutions, community groups, and public bodies to promote shared learning and community development.

10. To conduct leadership and capacity building programs aimed at empowering youth, women, educators, and community workers in alignment with the company's social mission.

11. To promote education and awareness through creative

expression, including street plays, art, music, storytelling, documentaries, and media campaigns related to the objectives of the company.

12. To coordinate with local and regional authorities and public institutions for effective implementation of socially relevant programs and to comply with applicable statutory requirements.

13. To document and disseminate best practices, impact stories, and learnings that can contribute to social awareness and improvement in areas related to the company's objectives.

Provided that the company shall not support with its funds, or endeavor to impose on, or procure to be observed by its members or others, any regulation or restriction which, as an object of the company, would make it a trade union.

5 (i) The profits, if any, or other income and property of the company, when-so-ever derived, shall be applied, solely for the promotion of its objects as set forth in this memorandum.

(ii) No portion of the profits, other income or property aforesaid shall be paid or transferred, directly or indirectly, by way of dividend, bonus or otherwise by way of profit, to persons who, at any time are, or have been, members of the company or to any one or more of them or to any persons claiming through any one or more of them.

(iii) No remuneration or other benefit in money or money's worth shall be given by the company to any of its members, whether officers or members of the company or not, except payment of out-of-pocket expenses, reasonable and proper interest on money lent, or reasonable and proper rent on premises let to the company.

(iv) Nothing in this clause shall prevent the payment by the company in good faith of prudent remuneration to any of its officers or servants (not being members) or to any other person (not being member), in return for any services actually rendered to the company.

(v) Nothing in these clauses (iii) and (iv) shall prevent the payment by the company in good faith of prudent remuneration to any of its members in return for any services (not being services of a kind which are required to be rendered by a member), actually rendered to the company

Once at least in every year, the accounts of the company shall be examined, and the correctness of the balance-sheet and the income and expenditure account ascertained by one or more properly qualified auditor or auditors

10 If upon a winding up or dissolution of the company, there remains, after the satisfaction of all the debts and liabilities, any property whatsoever, the same shall not be distributed amongst the members of the company but shall be given or transferred to such other company having objects similar to the objects of this company, subject to such conditions as the Tribunal may impose, or may be sold and proceeds thereof credited to the Rehabilitation and Insolvency Fund formed under Section 269 of the Act.
